# STATEMENT OF THE DIRECTRESS LOOKING INTO THE FUTURE

CICS.NOVA was founded in 2015 with an ambitious mission - to develop high-quality, interdisciplinary research innovative that fosters critical thinking in the Social Sciences and policymaking. Being based at the School of Social Sciences and Humanities (FCSH) of Universidade NOVA de Lisboa, with four regional poles at other higher education institutions, seemed a major plus from the very beginning. In March 2020, I became Directress of CICS.NOVA with a wonderful team by my side: six Research Groups coordinators, with whom I have been sharing my experience in the Direction of CICS.NOVA and with whom I have learned. Allow me also a special word to the regional poles coordinators that actively participate with a critical reflection on the complex problems with which the centre has been faced during the current biennium.

We had a common goal – to transform CICS.NOVA into a social sciences research institution recognized worldwide for embracing creativity and fostering freedom to chase interdisciplinary research in social sciences, to promote critical thinking and disseminate the acquired knowledge in the concerned communities, both on the national and international level, namely through the action of its regional poles. Our vision was, and continues



to be, to attract the most curious minds with ambitious research portfolios but, above all, to maximize every available resource, to boost creativity and productive action towards the future. As such, we implemented several changes in research support services, and we are proud to say that, even though this has been a hard journey, the results began to emerge and follow a successful path. Most of this success must be credited to the entire Science and Technology Management team for their professionalism, dedication and, above all, resilience in a complex context of difficult articulation between the different research groups and regional poles. The way that this team has been coordinated, helped to demonstrate that an excellent science administration must be a treasured component of high-quality research. It is with the feeling of starting to accomplish our role as an executive team at CICS.NOVA that we entered 2022.

But let me tell you a little about the journey of these last two years. In early 2020, we began as a new team. By then, "looking into the future" was the expression stuck in our minds to continue pursuing our goals. However, 2020 turned out to be quite different from what we expected. With the COVID-19 pandemic expanding globally, major restrictions on daily life have been implemented to prevent the spread of infection. The pandemic transformed the way we worked, from campus shutdowns, meetings postponed and/or moving to the virtual world. Social problems and disparities increased, and we realized the importance and urgency of a social sciences' perspective on COVID-19 times. Social scientists of CICS.NOVA, as well as researchers from other institutions around the world, have been demonstrating that this is not just a health crisis. This crisis is also social and political and must be seen as a moment of rupture that will entail profound changes in our societies on a global scale.

Having said that, the past two years were times of accelerated changes, challenges, and opportunities for us all. Despite all obstacles, we managed to make 2020 and 2021 more than just the years of the COVID-19. Those were also the years of achievements, as well as adapting and rethinking on how we want to do science. These were good years for scientific recognition and successes, as well as adapting. As the 2020 report shows, although CICS.NOVA had to adapt to the pandemic restrictions, much has been done, not only concerning research activities but also regarding internal participation and the regular activities of governance and decision-making.

In 2020, there was a general increase in achievement indicators, namely in the number of articles published in high-impact journals (SCOPUS, WoS, Scielo, PubMed) and in

international journals in general. There was a pronounced internationalization of the outputs produced, including participation in international proceedings, that reflected greater participation in international scientific events resulting in publications that meet the peer review criteria. CICS.NOVA also submitted a higher number of research proposals, with a rate of success consistently above average. Advanced training activities and initiatives, in the framework of the graduate, Master's and PhD, but also in other formats, were carried on.

If there is a lesson to be taken from this pandemic, it is that innovation can certainly be inspired by accelerated changes and challenges. An impressive number of seminars and initiatives, mostly online, were organized, giving public expression to CICS.NOVA research and dissemination activities. We are now actively present at the main social networks (Facebook, Instagram, Twitter, and YouTube), giving real expression to CICS.NOVA research and activities and valuing them scientifically and socially, as poles of science/society interaction and/or knowledge transfer.



Looking into the future, whatever it brings us, we will keep working hard, committed to our mission. The success key to all of this has been the high-level of participation and commitment of CICS.NOVA researchers. Your contribution has been invaluable, and it has been very rewarding to realize that we can all count on each other. As scientists and citizens, we all should reflect on the lessons learned from these past two years of transformation in our lives and on which future we wish to build for science and society.

# **RESEARCH GROUP 1** SOCIAL INEQUALITIES AND PUBLIC ACTION



### **Coordinator** Dalila Cerejo

Concerning Publications – Papers in 2020, the RG1 published 3 papers in indexed scientific journals, one in a Scopus and WOS indexed journal; 6 papers in international scientific journals and 6 papers in national scientific journals. Regarding book publications, book chapters in national publisher with no peer review was the most expressive item, followed by book chapters in national publisher (4 publications), and book chapters in international publisher (2 publications).

The 2020 was the peak of the pandemic, and the initiatives and events developed within this research group were particularly affected. Hence there was only one event organised within the RG1.

A particular important indicator for the CICS.NOVA's activity and vitality regarding the Advanced Training were the 12 Master's theses and one PhD theses completed.

In 2020, our group had one R&D Project FCT selected, as part of a special COVID call (FCT GENDER RESEARCH 4 COVID 19), as well as two other funded projects 2, with European funding EEA-Grants.

# **RESEARCH GROUP 2** CITIZENSHIP, WORK AND TECHNOLOGY

In 2020, RG2 researchers' continued to be involved in competitive national- and European-funded research projects, focusing, for instance, on how platform-work impacts on workers' forms of representation and organisation, on the role of culture and art in political expression and participation in the public sphere, and on how high-risk social groups, such as children, youth and detainees, access and exercise their citizenship rights.

Our work resulted in 16 indexed papers (12 in Scopus/Web of science); 5 books; 20 book chapters and the coordination of 8 issues in scientific journals. In addition, 1 PhD was successfully completed, as well as 43 Master's theses.

In the last years, our group has been successful in several competitive R&D funding calls for individual and team projects and as a result, in 2020, the group has one Marie Curie fellowship, one Jean Monnet Chair and projects funded within Erasmus+, Creative Europe, H2020 and FCT among other programs. Additionally, RG3 runs several projects commissioned by civil society institutions. Many projects include policy recommendations and/or the co-creation of knowledge.

Our work resulted in a relevant number of publications, including 22 scientific articles indexed in Scopus and Web Of Science in a total of 42; 28 book chapters, 8 of them indexed; 7 organized books, 2 indexed and 7 journal issues, 3 in indexed journals.

6 PhD students and 26 Master's students defended their thesis under the supervision of our researchers.

During 2020, the group published 41 articles in peer-reviewed journals, 21 of which in Scopus and/or WoS indexed journals (5 Q1, 3 Q2, 10 Q3, 4 Q4). The group authored 31 book chapters, edited 7 books, organized 2 conference proceedings and published 25 peer-reviewed papers on international (21) and national (4) proceedings. RG6 also put out 8 Policy reports, on such subjects as e-learning during the pandemic crisis, intercultural mediation, knowledge tools directed to students with special educational needs, and educational strategic plans for municipalities, among others. Over the same period, 5 PhD theses and 21 Master's dissertations were defended under the supervision of RG6 researchers. The subjective well-being (SWB) of children in out-of-home care is crucial to assess their potential quality of life. This study compares SWB of children in residential care and in foster families in Portugal and Catalonia. Results indicate that children in residential care have a lower SWB compared to children in the foster care groups, in both territories. These results should challenge public policymaking for children to change from an attitude dominantly in favor of institutionalisation to a more successful approach based on family foster care. #### Abstract

The subjective well-being (SWB) of children in out-of-home care is crucial to assess their potential quality of life today and in the future. This study aims at comparing SWB of children in residential care and in foster families in two European territories or jurisdictions: Portugal and Catalonia (Spain). This study used a sample of 551 children, aged between 11 and 15, being 39 in foster care and 145 in residential care in Portugal, and 41 and 326 respectively in Catalonia. SWB was measured with the Personal Well-being Index-School Children (PWI-SC9) and other variables were evaluated, such as happiness with the placement, relationship with carers, satisfaction with school, and perceptions about themselves and their lives. Results indicate that children in residential care have a lower SWB, as well as lower scores in most of the other variables, compared to children in the foster care groups in the two territories. 

CICS.NOVA is supported by the collaboration of eight Science and Technology Managers, distributed by the institutional partners (Universidade NOVA de Lisboa, Universidade dos Açores, Universidade do Minho, Instituto Politécnico de Leiria, and Universidade de Évora), that generates support for scientific research.



The science management team collaborates in the administrative and financial management of the research unit; in the pre-award research administration (finding funding; budget creation; filling out proposal forms; submitting the proposal; etc.); in the post-award research administration (project managing; financial compliance monitoring; monitoring, reporting; and billing); in editions management; and in science communication activities.

# TRAINING @ CICS.NOVA | FOSTERING NEW CRITICAL THINKING

Regarding running Advanced Training, CICS.NOVA has 10 Doctorate offers that provide a wide range of scientific areas. #### INCENTIVE TO SCIENTIFIC PRODUCTION - RESEARCH FELLOWS

Although it was created in 2020, the Incentive to scientific production for research fellows was only applied in 2021.

This incentive aims to support scientific activities of PhD researchers that contribute to CICS.NOVA scientific strategy and applies to proposals for activities to be developed in 2021. This incentive is open to all doctoral researchers, with a maximum value of 500 Euros/Researcher, in the following areas: Publications and Participation in scientific events, including schools or summer and winter courses. The evaluation of the proposals takes into account the adequacy of the proposal to the specific objectives set out, its articulation with the researcher's CV, its feasibility and its scientific relevance.

#### **CICS.NOVA INITIATIVES**

Every year, CICS.NOVA organizes an Openday to all Master's and Doctoral students associated with our offer. In 2020 the Openday was online and was highly participated. CICS.NOVA was also involved in the 2020 NOVA FCSH Summer School.

CICS.NOVA was also involved in the European Researchers' Night initiative.

### COVID-19

The COVID-19 Pandemic, which started in December 2019 in Wuhan (China), has profoundly disrupted our societies on a global scale. Since that moment, we have been facing serious. complex, and interrelated health as well as social and economic challenges that imposed significant changes on different levels. Along the public health crisis, came a social crisis. Therefore, besides the important role of the biomedical sciences to contain the spread of the SARS-CoV-2 infection, the crucial contribution of the social sciences to better understand and deal with the multidimensional impacts (political, socioeconomic, and psychological) of the pandemic is also largely recognised.

At first, during the immediate response to the health crisis, analysing the management of the pandemic in the emergency phase and the nature and extent of the disruptions it introduced in various domains. At a later time, with a shift in focus to a future horizon, systematizing the lessons to be learned and exploring the transforming agenda that the post-COVID-19 era can entail. This transforming agenda can be at the political, socio-cultural, economic, technological, health and environmental levels, introducing a new "normal" in the medium and long term.

On June 5, 2020, shortly after the outbreak of the COVID-19 pandemic, the board of CICS.NOVA decided to create a digital platform to function as a repository of content related to what is being produced by its researchers around this issue. The digital platform - Social Sciences Lab been acting as an integral part of the science communication and dissemination efforts of CICS.NOVA. It encompasses scientific publications, presence in the media (opinion editorials, interviews, and debates), participation in and organization of in-person or online events, as well as funded research projects coordinated by CICS.NOVA researchers.

The scientific contributions of CICS.NOVA researchers to discuss and reflect upon these unprecedented pandemic times in the light of social sciences have been prolific. These have sometimes taken the form of conceptual reflections of a more general nature, but have mainly focused on specific topics: the process of adaptation to distance learning, teaching strategies, and adaptation of informal communities of practice; levels of literacy in science and health; the prevalence of gender violence domestic violence: the different and pandemic temporalities; telework, burnout, networking, and the accentuation of social inequalities (especially the rising unemployment and the poverty); (re)organization of healthcare systems and training of health care professionals; the impact of isolation/confinement on young and old people (either in their own homes or in residential structures for elders); life in the cities and rural areas and geographical particularities; implications on tourism, housing policies and nightlife sector; food diet and environmental farming, challenges; governmental mass surveillance and social activism.

- "VD@Covid19 - Violência nas relações de de Covid-19: intimidade em tempos desigualdades de género e (novos) violência contornos da doméstica", coordinated by Sónia Dias and with the participation of Maria João Leote and Vera Duarte (CICS.NOVA as partner);

- "#Unstereotyped: Análise, avaliação e detecção automática de linguagem estereotipada na comunicação pública de prevenção e combate à COVID-19", coordinated by Rosalina Pisco Costa.

majority Nevertheless, the of the contributions are on a specific topic and rarely involve researchers from different RGs. Therefore, the COVID-19 Social Studies Hub, created within the set of initiatives developed in 2020 by the Labid – Laboratory of Ideas, aspires to be an interdisciplinary collective in the field of social sciences, which aggregates and creates synergies between CICS.NOVA researchers who are developing studies and/or reflections on the societal impact of COVID-19 pandemic on ways of life, organizations, and territories. It will thus work in close coordination with the COVID-19 Social Sciences Lab, but it intends above all to promote a program of joint integrative and multilateral activities within the scope of CICS.NOVA, covering the research, aspects of training, and networking around this theme.

This Hub will seek to be a driving force for research aimed at the production of scientific knowledge on this topic, always focusing on the transversality of approaches on the articulation between the various Research Groups, on the connection of


CICS.NOVA with the civil society and, equally, in the greater visibility of the centre and of its work. One example was the Autumn Labid Talk held in December 2021, with Márcia Grisotti (University of Santa Catarina, Brazil) as Keynote Speaker, on "Contaminated Death: The experience of death by Covid-19 from the perspective of health professionals". The featured initiative also two other participations from CICS.NOVA researchers who presented the results of their research on the impacts of the COVID-19 pandemic on the life of cities and on higher education, respectively.

During 2020, preparatory work also took place regarding the organization of online events such as the cycle "Ciências Sociais à Conversa", which aims to create a space for dialogue between social sciences and civil society actors. "Rethinking the reactivation of the nightlife sector in times of pandemic" was the theme of its first session, held in July 14, 2021, with the participations of Jordi Nofre (CICS.NOVA, NOVA FCSH), Paula Guerra (Institute of Sociology, University of Porto), Gonçalo Riscado (Musicbox, CTL) and Daniel Pires (Maus Hábitos).

# SCIENCE IN SOCIETY


2020, was the year when CICS.NOVA started to participate more actively in social media. The project "JOVITEMPREGO - Trajetórias de desemprego, vivências e percursos de vida dos jovens na ilha de São Miguel" aims to study and define intervention strategies to address the impacts of unemployment on the life trajectories of the Azorean youth. This project is a partnership between CICS.NOVA, Fundação Gaspar Frutuoso and the Universidade dos Açores. It is financed by the Direção Regional da Ciência e Tecnologia (Açores).

The project "**A-Place**" is a co-creation project aiming to strengthen the bonds between people and places through the development of site-specific art, creative spatial practises and cultural projects. It is financed the Creative by Europe programme of the European Commission and involves multiple stakeholders including universities. civil society associations, municipalities, among others.

The project "<u>VITIPOLIS - A Segurança na</u> <u>Cidade de Lisboa</u>" aims to develop proposals to improve the Community Policing program in Lisboa and to contribute for the development of public policies tools of crime prevention and policing models promoting participatory citizenship. The project "**ESCXEL – School Network for Excellence**" is based on a partnership between CICS.NOVA, municipalities, school units among other social actors. Its main goal is to foster a continuing endeavour to improve quality and performance in its schools. It is financed by the municipalities of Amadora, Cascais, Castelo Branco; Constância, Entroncamento, Ferreira do Alentejo, Mação, Oeiras, Sardoal, Sertã and Vila de Rei. It is further supported by the Secretaria Regional de Educação of Madeira, by EPIS- Associação Empresários pela Inclusão and by the Comunidade Interrmunicipal do Médio Tejo.


